Denounced and acquitted: this is how they try to intimidate non-aligned journalists [10 June 2020 Cesare Sacchetti 10 Comments](#)

Yesterday afternoon, as I usually do, I opened the PEC that is generally assigned to members of the order of journalists and I found an unwelcome surprise.

The order in fact informed me of the outcome of a disciplinary measure that concerned me and of which I knew absolutely nothing, when this had already been opened on 8 April.

Reading the three-page PDF communication ([link here](#)), I learnt that a complaint had been lodged against me with the Lazio Order of Journalists for a post made on Facebook on 8 April.

The post in question concerns the video I had shared on my social pages, Twitter and Facebook, showing the Humanitas-Gavazzeni hospital in Bergamo completely empty, both in the emergency room and in the tent structure where Covid patients were supposed to be housed.

The offending post

I felt it was my duty to share it in order to show the public what the mainstream media did not want them to see, namely a situation of complete normality.

The climate at the time, not unlike now unfortunately, was one of full-blown health terrorism.

The media were united in their effort to portray Italian hospitals as collapsing due to the so-called Covid crisis, and the video in question, shot in one of the cities where there was the most significant anomaly of deaths compared to the previous year, dismantled this emergency and terrorist narrative.

Apparently, a guy named Roberto Fabbrucci did not like it when the facts were revealed and went to the order to file a complaint against me.

Typing the name of this person on Google brings up the name of a journalist from Treviglio, in the province of Bergamo, but I have no certainty that it was him or rather one of his namesakes who approached the order about my post.

If that were the case, it would be even more serious because a journalist, rather than doing his job, is acting against another colleague who is only providing information. In any case, the disciplinary council of the order examined the complaint in question and concluded that there was absolutely no basis to conduct a process against me.

In the video and in my commentary on the images, all that is being done is to document the state of the hospital. There is simply reporting, which Mr Fabbrucci evidently does not like to see done.

It is the members of the disciplinary board themselves who explain this clearly.

"The Board, after having taken note of the above, has had the opportunity to watch the video recorded on 27 March at 11.47 a.m., lasting 1.48 minutes, and has come to the conclusion that the author of the video has repeatedly pointed out that he depicted what he had managed to film, mainly in the part of the inner courtyard of the Gavazzeni-Humanitas hospital, i.e. an empty marquee with neither patients nor staff inside it.

It must be pointed out that the author of the report emphasised that what was reported concerned what in fact anyone could have seen at that precise moment (at 11.47 a.m. on 27 March 2020), moreover without adding any comment, positive or negative.

Therefore, this collegium has come to the conclusion that the author of the report merely photographed the situation without adding anything and therefore only exercised a right to report.

As a result of the above, it is deemed to dismiss these proceedings, in relation to the complaint, as no breaches of ethical rules have been highlighted'.

That was that. I have done nothing but do my job, exercising my right to report the news as any other journalist should.

But I realise that in these anomalous times we are living in, the problem is not those who in bad faith distort the facts and start a media campaign based on terror and often on false information.

The problem is those who try to do their job, showing what the mainstream media does not want the public to see.

Next time I guess I will have to ask for Mr Fabbrucci's consent before sharing a video or post.

Anyway, [after the attacks by Newsguard](#), the American company with the macroscopic conflicts of interest, comes another attack that again turns out to be a complete failure.

The official sources are not committed to exposing the truth and the lies that have been told in recent months, because they themselves have been at the forefront in spreading lies and describing a deadly virus that does not in fact exist.

The proof of all this? It comes from the Ministry of Health itself. Did you see the terroristic headlines about the death toll from Covid and the usual civil defence war bulletin reporting the death toll?

Well, forget all that.

The Ministry of Health has published this announcement on its official page regarding the number of people who have died from the Coronavirus.

In other words, is the ministry saying that it officially does not know whether these people died from the virus, because this can only be ascertained after autopsies have been performed?

So what has this been all about these months? A country has been closed down and a police state established without even knowing the cause of death of these people, all of whom, [according to the ISS itself](#), had co-morbidities.

Incidentally, how can autopsies be performed if many of the bodies were cremated and [if the Ministry of Health itself recommended not to do them](#)?

Generally, this is not the behaviour of someone who wants to shed light. This is the behaviour of someone who wants to cover-up, hide the truth and erase the traces. If there were a magistracy, all this would probably be the subject of judicial investigation, but if the magistracy is the one that is emerging from the Palamara case, it is not surprising that nothing is happening because this body appears contaminated to the core by the 'stench of moral compromise', to borrow the words of a great magistrate who was discredited and defamed by his own colleagues during his life, Paolo Borsellino.

With a free press and a judiciary at the service of the people, all this would be a national scandal that would be talked about on the front pages of every newspaper.

With a regime press and a judiciary at the service of the large transnational lobbies, the enemy is not the scandal or the lies of this system.

The enemy is those who denounce them.
