Covid patients killed by lethal drugs in Scotland: is this the unspoken truth about the Bergamo massacre?

Lies were clearly at the heart of this complex terrorist operation from the very beginning. It was so from the moment the media started writing that the first Covid case of death, that of Adriano Trevisan, had actually resulted from the 'Wuhan virus'.

Nothing was true, and they did not even wait for the autopsy report on Trevisan to establish with certainty what had actually happened to the 76-year-old from Veneto.

By the time the autopsy arrived, however, the lie had already been written by every media outlet and had not been denied by them with the same intensity and clamour with which it was reported in February 2020.

Adriano Trevisan [did not die from Covid but from other causes related to his previous health problems](#).

The media's only task was to lie and terrorise, in a strategy very reminiscent of the one practised by the infamous Bush administration at the time of the Iraq war called 'shock and awe'.

The Conte government, through its policy of authorising that macabre truck parade in Bergamo, wanted precisely to shock the Italian public, and the media who, rather than denounce the absolute gravity of what was happening in Bergamo, did everything instead to terrorise Italians and convince them that that virus killed with extreme ease.

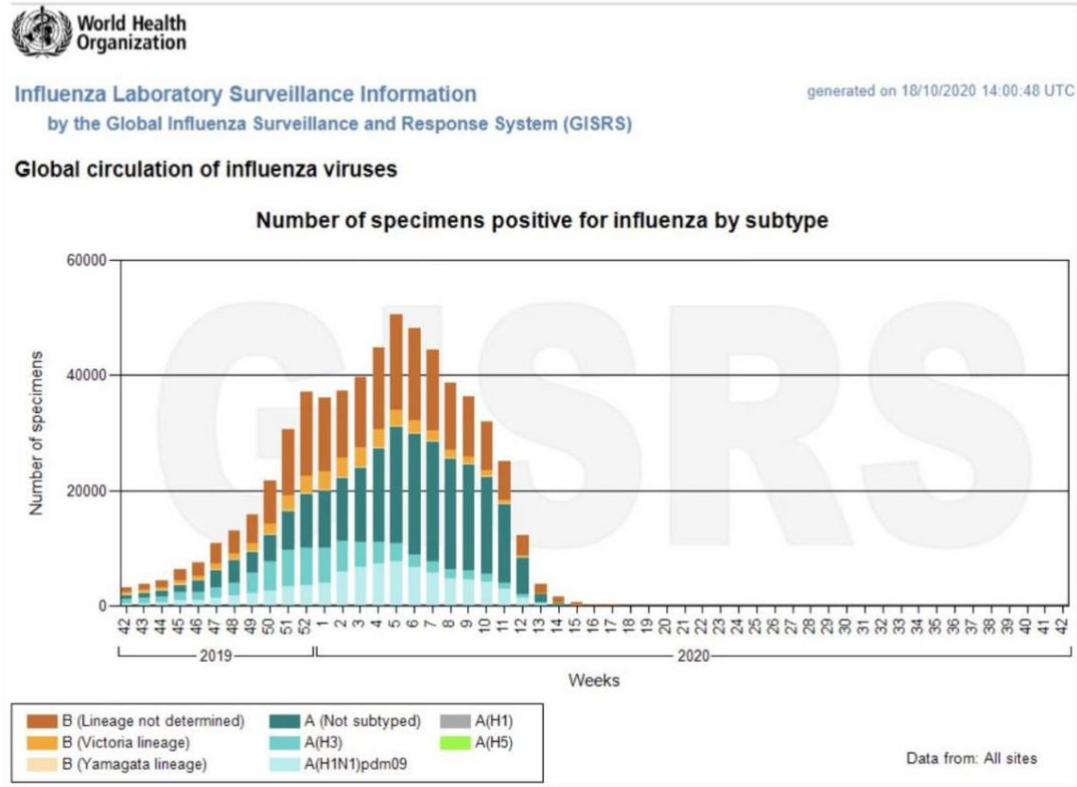

Again, health logic has nothing to do with house arrest because even if you believe there is a dangerous virus out there, the solution is certainly not to lock people up at home but to let them circulate so that herd immunity matures.

Our bodies are designed to protect us through our immune systems but those who were in power at that time and a horde of self-styled corrupt doctors - who in some cases even struggled to pass the state exam to become a doctor - were spreading at full force the false idea that we should not go around because we were dying.

It was true that people were dying in hospitals in Lombardy, not of Covid but of other causes on which the judiciary is obviously doing nothing to shed light as usual.

Scottish nurse's complaint: Covid patients killed by drugs

A glimmer of truth about the Bergamo massacre may come from what recently emerged in Scotland.

The story seems to be a photocopy of the one in Bergamo only written in even more explicit terms.

There is a nurse in Scotland, Lesley Roberts, [who is trying to bring out the truth about what happened in the country](#) at the time of the coronavirus terrorist operation.

The Scottish nurse has just received a restraining order from the Covid Commission of Inquiry forbidding her to disclose the information she has on the healthcare protocols performed on coronavirus patients.

This does not seem to have stopped the courageous woman who seems intent on bringing out the whole truth about what happened at the time, so much so that it prompted her to accuse Scotland's first minister, Nicholas Sturgeon, of a massacre.

At the time, in Scotland, NICE, the acronym for the National Institute for Health and Health Excellence, had issued a very specific health protocol for Covid patients defined by the acronym NG163.

This code concealed nothing more than a procedure that applies to terminally ill patients suffering from incurable diseases that reach their last stage and unfortunately leave patients with very little expectation of life.

NG163 provides for the patient to receive a cocktail of drugs that should only be administered in the most extreme cases mentioned above. Instead, the Scottish Health Institute decided that this procedure should also be applied to Covid patients who, in the vast majority of cases, were not in the last stage at all but instead presented symptoms of the common flu.

When, therefore, these drugs are administered to people who have nothing particularly serious, it cannot but be obvious that there is a murderous intent behind such a decision. This is exactly what Lesley Roberts is trying to denounce. She expressed herself on the subject as follows.

"It (procedure NG163 ed.) should never have been considered. People who were not near the end of their lives were led to their death by these drugs. If they had breathing difficulties, then their breathing was suppressed even more by the drugs and that is what killed them, not Covid."

It seems impossible that what Roberts knew was not in turn known by the Scottish doctors who carried out these legal protocols, and it seems equally impossible that the bodies who established these murderous directives were not aware of it.

This, then, takes us away from the medical level, which is all but absent from the COVID story, and inevitably into the political one.

Once it has been ascertained that COVID was a name chosen to define the common seasonal flu and once it has been ascertained that it was never really dangerous, it is clear that if one decides to administer these drugs to patients it is to kill them.

If then, once this mass slaughter is practised, one falsely claims that these patients died from Covid one is clearly lying to support a false pandemic narrative that had purely political aims. To us and others, this was clear from the first moment.

When one pauses to read the pages of the [2010 document published by the Rockefeller foundation and titled 'Operation Lockstep'](#), where lockstep is the term used in English to describe something that takes place at a rapid pace, it is clear that one immediately realises that the ultimate goal of the 'pandemic' described in this document was to give birth to a global authoritarian political system, the so-called New World Order cited countless times by various exponents of globalism.

The massacres that took place in various countries and were falsely attributed to Covid were therefore political and not health-related in nature since if one decides to give lethal drugs to relatively healthy patients or those with various treatable diseases there is clearly no other purpose than to kill them.

What happened in Scotland may be the key to understanding what happened in Bergamo. We know that [the judiciary conducted an enquiry into those deaths](#), but that enquiry was based on false premises from the outset and its purpose was not to seek the truth, but to avoid it at all costs.

The investigation by the Bergamo public prosecutor's office started from the false premise that the former premier Giuseppe Conte and his health minister, Roberto Speranza, could have caused the massacre by failing to promptly adopt the infamous red zones, i.e. mass closures, in the Bergamo area.

The investigation is based precisely on the lie on which the entire coronavirus terrorist operation was conceived, namely that of the 'lethal virus' in circulation and the closures necessary to avoid 'contagion'.

Having established, as mentioned above, that in 2020 there was nothing else in circulation but the common seasonal flu, a real investigation should have established what the people in Bergamo really died of.

There are testimonies from relatives on the social networks that have been completely covered up by the media, reporting that something extremely abnormal was going on in the hospitals where their loved ones were admitted.

From night to morning, people died who were not in a critical condition at all. The truth is all inside the bodies of the victims, and the circular of the Conte government that 'suggested' the destruction of those bodies [by cremation] is at the very least suspicious, to use a euphemism, because even if one believes the false narrative of death by Covid, those bodies should not have been burned but carefully analysed to understand the causes of the deaths. Instead, [directives were issued](#) from Palazzo Chigi and the Ministry of Health ['recommending' that those bodies be disposed of](#), and this should have raised serious questions in any critical and conscientious magistrate.

These are rare characteristics in the Italian judiciary, since the Constitution of 1948, written [by several Freemasons such as Piero Calamandrei](#), conceived a current judicial body dominated by Masonic logic and out of any real and effective control of the State, in turn reduced to an abstract entity by the liberal-democratic system created by the Anglo-American powers that dominated Italy and Europe after the end of the Second World War.

To us, the truth about the Bergamo massacre seems inescapable, as we said at the beginning of this article, and we believe it is everyone's duty to ask what really happened in March in the town of Bergamo.

And we believe, at the same time, that the real perpetrators of that massacre cannot fail to pay.

Italy and the Italians, in order to leave behind the nefarious historical phase of the last few years and to turn the page once and for all, need to know which criminal minds have governed this country and how these minds have deliberately killed innocent people in order to achieve their ends.
